The price for using the car is sum of the price for the reservation time, kilometers, booking rate and possibly additional insurance. The time of the reservation is charged according to the entered reservation (see also Cancellation fee). The minimum duration of the reservation is half an hour, each half hour started is charged. The price of a multi-day reservation is made up of the sum of the price for the first day, the price for the second and third day and the price for the fourth and other days. We consider one day to be 24 hours from the time of reservation. The price per distance is made up of the sum of the prices for driving up to 200 km, then up to 500 km and over 500 km.

The additional insurance "Jistota plus" equaling the price of one hour of your reservation reduces your maximum deductible to CZK 5,000. The price does not change according to the length of the reservation or the number of kilometers driven, it depends on the category of the car only. We will activate/deactivate the additional insurance for you based on a request on the helpline or by email and it is valid from the moment your request is approved. "Standard" insurance is automatic and free in the standard price of the service. The total damage is considered without VAT, the amounts charged are with VAT at 0%.

## Cancellation fees

Deleting or editing a reservation before it starts	free of charge
Shortening after the start by more than half an hour	the last unused hour or half an hour is not charged
Shortening after the start of the reservation by more than 24 hours	it is charged a maximum of 24 hours from the new end of the reservation, the rest of the reservation is not charged
Unused reservation	it is billed in full resp. shortened by the last hour

The valid start of reservation is set by you in the reservation application. Boarding the car is not considered the start of the reservation. In case of early termination, the car will appear as available for other users. This fact does not change the above conditions in any way, ie. the remaining time of your reservation is charged to you.

## Entry conditions

The refundable deposit is due after signing the framework contract and is returned in full only in case of withdrawal from the contract. The deposit cannot be used as credit to pay for the normal use of the car.

An entrance fee (non-refundable) can be applied in justified cases instead of a deposit, details are always given in the framework contract and/or price list.

### Eligible expenses towards the vehicles <sup>(5)</sup>

### Examples of trips

A two-day business trip or a weekend trip. You reserve a car for 34-48 hours and drive a total of 220 kilometers in a Standard category car. You will pay for the trip: 95 CZK entry fee + 950 CZK/1. day + CZK 850/2. day + CZK 1,700 for the first 200 km (CZK 8.5/km \* 200 km) + CZK 160 for the next 20 km (CZK 8/km \* 20 km) = CZK 3,755. (Plus any additional "Jistota plus" insurance for CZK 95.)

A nine-day holiday where you leave on Friday afternoon and return the following week on Sunday afternoon. You will have a Comfort category car for 216 hours and drive 1,500 km. You pay: 119 CZK starting rate + 1190 CZK/1. day + 2\*990 CZK/2. and 3rd day + 6\*890 CZK/4.-9. day + 1800 CZK for the first 200 km (9 CZK/km \* 200 km) + 2550 CZK for 200-500 km (8.5 CZK/km\*300 km) + 6500 CZK for 500+ km (6.5 CZK/ km \* 1000 km) = CZK 19,479. (Plus possible additional insurance "Jistota plus" for CZK 119.)

A shorter trip around town with grandma to the doctor or a big shopping. You book Economy for 4 hours and drive a total of 20 km. You will pay for the trip: 75 CZK starting rate + 75 CZK/h \* 3 h + 8 CZK/km \* 20 km = CZK 460. (Plus any additional insurance "Jistota plus" for CZK 75.)

- (1) Price for the distance driven is calculated as the sum of the price for kms up to 200 plus the price for kms from 200 to 500 and plus price for kms above 500.
- (2) Price for reservation of more days is the sum of the price for the 1. day, price for the 2. and 3. day, and of the price for the 4. and next days. Minimum reservation time that is charged is 30 minutes. The time of reservation is charged as it was inputted into the reservation system (or changed in due time) at the moment of its start. The start of the reservation is set by the user in reservation system and does not equal the moment of opening the car. If you return the car earlier, the last unused hour or half of an hour is not charged. When prolonging or cancelling your reservation after it has begun, maximum of 24h is charged counted from the newly set end of reservation or from the moment of deletion or shortening of the reservation. Besides the above NO SHORTENING of reservations are considered in the price.
- (3) Booking charge is charged for each valid reservation.
- (4) In case of suspicious or illicit behaviour of a user towards Autonapůl, družstvo, it is possible to issue an invoice immediately after the trip or even before the trip with an appropriately shorter invoice due date.
- (5) Eligible expenses are deducted from your regular invoice upon submission of a receipt or other proof of payment. Repayment of expenses may be delayed by up to 90 days due to administration.
